Please note that, due to the recent transition to the new GLOBALG.A.P. IT platforms (**CertifierOS and Supply Chain Portal**), it is no longer possible to update certification status in the GLOBALG.A.P. Database. NSF Certification UK Ltd is actively working to ensure a smooth transition to these new platforms. The process requires additional operational time, as audits originally conducted in the previous database must be manually recreated and re-certified in CertifierOS before validity extensions can be processed.

We also confirm that the producer group has accepted a re-certification audit for the next certification cycle.
